### **DEVELOPMENT**

#### sia.tech

We launched our new website, which illustrates the project's refreshed aesthetic, simplifies the layout and content, and piques the interest of newcomers.

## renterd and hostd

We moved up our release timeline for **renterd** and **hostd**. These binaries were originally slated for release alongside v2; we now intend to launch v1-compatible beta versions in Q3. This will bring important renter and host improvements to users earlier, and will smooth the transition to v2.

#### explorer

Recognizing the need for an independent blockchain explorer stewarded by the Foundation, we launched a reskinned version of the SiaStats explorer, and have begun work on a new explorer architecture.



### **OPERATIONS**

#### 501(c)(3) Approval

We received official recognition of our 501(c)(3) status from the IRS. With our legal status now aligned with our internal vision of the company, we will continue advancing our mission of user-owned data.

## Web 3 Foundations

We met with industry peers to share our experience building a crypto non-profit at the Web3 Foundation Unconference.

## Hosting memo

We solicited a memo evaluating the legal landscape for hosts based in the U.S. and other jurisdictions. We are pleased with the results of this inquiry, and intend to share a summary of the findings early next quarter.

#### **Skynet Summer Program**


We approved a grant to Skynet Labs, funding a summer program that will incentivize development of new apps within the Sia ecosystem. All of the funds will go directly to developers in the community.







### **FINANCIALS**

#### USD and SC Spending



We converted approximately 394 MS in Q2, tapering off as we approach our USD budget goal. With our current asset portfolio, we feel confident in our ability to continue operating regardless of market conditions.

## **NEXT QUARTER**

#### **Continue CSO search**

Expand our search, drawing on existing networks and boutique recruiting firms, to identify high-quality candidates for this crucial role.

#### **Publish new binaries**

Refresh Sia's core software ecosystem by releasing beta versions of renterd and hostd, and iterate their APIs and UX according to user feedback.

#### Launch grants program

Replace our ad-hoc grant application process with a proper framework for receiving, reviewing, and approving grants.
